A petition was presented to the court to approve adding Monkey Bluff Road and Deer Farm Road to county maintenance. Motion was not approved due to lack of a motion. Magistrate JV Groce stated that he personally has not spoken to anyone concerning this petition and did not want to make a decision at this time. Let the record show no action taken.

ITEM 1

Visitors:

Robert Capps presented the Cumberland Co jailers report for October. 35 runs to Adair Co., 1 run to Pensacola FL., 2 runs to Hardin Co., 1 run to Decatur TN., 2 runs to Russell Co., 2 runs to Grayson Co., 1 run to Barren Co., 1 run Taylor Co. For a total of 45 runs at 4,743 total miles. As of November 1, we had 32 inmates in Adair Regional Jail and 1 in Taylor Co. Detention Center. During the month of October we had 4 on house arrest for total of 35 days with a savings to the county of \$1,105.00.

Scot Daniels stated that he hoped to have his office's new vehicles within the next week. He discussed radios and repeaters. Sheriff Daniel's will be testing for 60 days a repeater and if it works, he will be looking for grants to purchase more. This will also help with the school system bus garage.

Coroner Gary White spoke about the rise in the drug problems across the state of Kentucky. White stated the coroner runs are up and he expects the drug related runs will be up 50%. White has requested that the county bond a second deputy coroner, Michael Spears. Motion by JV Groce, seconded by Thomas Brown. "All Voting Aye". Motion carried.

The court discussed the Partner with Pride project initiated by Molly Morgan. She has been working with Todd Davidson who has drawn out a design to spruce up the landscaping around the courthouse including lighting to illuminate the courthouse. The project would cost approximately \$4,800.00. The court will discuss this further at the December meeting.
