Saban Lane was approved by the court to be put on the county road maintenance system. Motion by J V Groce, seconded by Earl Branham. "All Voting Aye." Motion carried.

Court approved to close a portion of Dug Road. The change in distance is now .60 mile. Motion by Thomas Brown, seconded by Edward Anderson. "All Voting Aye". Motion carried.

ITEM 2

Visitors:

Jailer Junior Smith presented the Cumberland Co jailer's report for December. 45 runs for the month of December. 40 runs to Adair Co., 2 to Oldham Co., 2 to Barren Co., 1 to Wayne Co., for a total of 3,430 total miles. As of January 1, we had 28 inmates in Adair Regional Jail and 1 in Taylor Co. Detention Center. During the month of December we had 7 on house arrest for total of 135 days with a savings to the county of \$3,780.00.



Cumberland County Coroner Gary White gave his 2016 report. There were 141 deaths in Cumberland County in 2016 with 34 of those worked by the coroner's office. There were 9 cancer deaths, 12 heart related deaths, 6 natural causes, 1 accident, 1 homicide, 1 logging, 3 suicides, and 1 overdose death.

Cumberland County Clerk Kim King asked the court to help her find space to store her office records. Clerk King stated she is running out of space in her office.

Cumberland County Sheriff Scot Daniels reported back to the court that the repeaters that were installed in December have been a great help to the office. Sheriff Daniels reported that the meth complaints were on the rise. Also, he addressed the issue of two officers involved accidents in the past 2 weeks.

ITEM 3

Court approved the second reading and final adoption of Amendment #2016/17-05. Motion by J V Groce, seconded by Earl Branham . "All Voting Aye." Motion carried.

ITEM 4

Court approved a resolution from the Kentucky Department of Transportation Discretionary fund for resurfacing of county roads. Magistrate Edward Anderson felt that the list of roads and the money for each district was not distributed equally for every district. Judge Phelps stated that the transportation department assigned the roads and money. Motion by Thomas Brown to approve resolution, and after the third call for second, J V Groce seconded. "All Voting Aye". Motion carried.

ITEM 5

The court discussed an agreement with the GreenRiver Animal Shelter for housing animals on a per animal basis for \$44.00 per animal. Court decided to wait on action concerning agreement with Green River until Tri County Shelter has made further decisions with their current situation with Wayne County. Court agreed to table. Motion by Edward Anderson, seconded by Thomas Brown. "All Voting Aye." Motion carried.
