In June we had 7 under house arrest for a total of 125 days. Saving the county \$3,750.00. Starting the month of July with 18 prisoners in Adair Co. Regional jail and 1 prisoner in Taylor Co. Detention Center.

Jerry Lyn Wheat stated that the new bailer and shredder was up and running at the recycling center.
